

# DUBOIS COUNTY PARK

## RULES AND POLICY

1. Clean up your area after use. Place trash in available receptacles.
2. Do not leave fires unattended. Fires must be extinguished before retiring for bed or leaving campsite.
3. Quiet time observed after midnight. Rowdiness and obscene/abusive language will not be tolerated.
4. No firearms of any type allowed.
5. Observe all rules and policies as posted. Only one table and one campfire/fire ring allowed per site. The Board maintains tennis courts for use **as tennis courts** by the general public. Observe the rules posted at the court entrance. Any abuse of these courts is strictly prohibited.
6. An adult must accompany campers under the age of 18. **No alcoholic beverages permitted for minors.**
7. Group parties for families or bona fide organizations with adult supervision only.
8. **Observe all traffic signs as posted! VIOLATORS WILL BE PROSECUTED!**
9. No ATV's/off-road vehicles allowed on any park property.

**FULL PAYMENT FOR DURATION OF STAY IS DUE WHEN THE SITE IS OCCUPIED.** Place fees in drop box in main restrooms building or pay at the Park Superintendent's office located on top of the hill at the East Side of the 4-H Fairgrounds. **NO REFUNDS.** Make checks payable to: **Dubois County Park**

11. Campsites are available on a first-come, first-served basis. A site is considered occupied when a camper or vehicle is in place and the site is paid for.
12. Maximum campground occupancy is 14 consecutive days. At the end of **any** camping period you must **vacate the park for 48 hours.** Check out time is 3 PM.
13. You may reserve Shelter House #1 (\$13.00/day) or #4 (\$8.00/day) up to one year in advance by calling **482-2434**. The reservation fee is due within 2 weeks of making the reservation or the reservation is voided. **All** other shelter houses are first-come, first-served. **Do not remove tables from shelter houses.**
14. Dubois County Park Board of Directors meeting dates are at 9 AM on the 2nd Tuesday of January, April, July, and October at the fairgrounds office. Public input is welcome.
