

**DUBOIS COUNTY COUNCIL**

**DECEMBER 29, 2010**

The Dubois County Council conducted its monthly meeting on December 29, 2010, at 5:00 pm, in the Council Chambers of the Courthouse Annex. Present at the hearings were Board members Gregory A. Kendall, Jerry R. Hunefeld, Mark A. Brescher, Scott J. Knies, Donna L. Schroeder, Bonnie J. Luebbehusen, and Martha A. Wehr, and Auditor Janet L. Sendelweck. President Kendall asked if there were any additions or corrections to the minutes of the last meeting. On motion by Martha A. Wehr, seconded by Jerry R. Hunefeld, the minutes were approved as written. The motion carried unanimously.

**RE: ADVANCED MANUFACTURING TRAINING CENTER COMMITMENT**

Commissioner John Burger appeared to request Council commitment of \$125,000 over 2 years toward construction of an advanced manufacturing training center on the Vincennes University Jasper Campus. The Commissioners unanimously voted to support the project. On motion by Jerry R. Hunefeld, seconded by Bonnie J. Luebbehusen, the Council unanimously approved pledging \$125,000 over 2 years from EDIT fund to the project.
