# REGULAR MEETING DUBOIS COUNTY COMMISSIONERS APRIL 10, 2012

The regular monthly meeting of the Dubois County Commissioners was held in the Commissioners' Room of the Courthouse Annex in Jasper, Indiana, beginning at 9:00 a.m. (EST) on April 10, 2012. Present were Commissioners Lawrence M. Vollmer, Randall L. Fleck, and Doug M. Uebelhor. Also present were County Auditor Kathleen M. Hopf, County Surveyor Ken Brosmer, Highway Supervisor Steven L. Berg, Highway Engineer Jason T. Heile, and County Attorney Arthur C. Nordhoff, Jr. A quorum was declared present and the meeting was opened for business by President Vollmer. Minutes of the March, meetings of the Commissioners were approved as presented. The minutes were then signed. Incomes for the month of March, were as follows: Recorder \$16,476.43; Health Department \$23,052.83; Auditor \$100.00; Clerk \$\_\_\_\_\_. Claims against the County were examined and those found to be just, due and owing were allowed and those found to be not due and owing were disallowed, all as more fully set forth in the Claims and Allowance Docket of the County.

The Commissioners, on motion duly made and seconded, approved the additional appropriation, subject to approval of the County Council.

## **RE: ST HENRY 5K**

Chris Lindauer of St Henry appeared to advise that the St Henry Sesquicentennial 5K race will be held on June 9, 2012, beginning at 8:00 am. After discussion of the route and race requirements, on motion duly made and seconded, the Commissioners authorized closing of CR 1100 S, 200 W, 1000 S and 100 W from 7:30 am to 10:00 am, with the exact times as to each road to be determined by the Race Committee and with the Committee to be responsible for traffic control and signage. Sheriff's office is to be contacted by Committee.

#### **RE: VOTING LOCATIONS**

Bridgette Jarboe appeared to report to the Commissioners the voting locations for the Spring elections. Changes were required because of precinct relocations and conflicts with old sites. Bridgette questioned jurisdiction as to site locations. The Commissioners approved sites as reported. The Clerk cited I.C. 3-11-8-3.

## **RE: WOOD PRODUCTS BUILDING**

Lisa Gehlhausen of Indiana Region 15 appeared to discuss funding programs which are currently open for properties owned by government entities. One program closes on June 8 and provides \$500,000 of funds with 10% required match, and the second program closes on September 7. The process requires public hearing and environmental reviews by eight State agencies. The application form is currently not available from the State. The Commissioners, on motion duly made and seconded, authorized Region 15 to proceed with steps required to file application for funding. The Commissioners provided a list of engineering firms to whom RFP are to be issued.

On motion duly made and seconded, the Commissioners authorized County Service Officer Johnson to attend the annual conference at Indianapolis on June 5-7, 2012.

## **RE: PAYROLL COMPUTER UPDATE**

The Auditor reported that State requirements will cause an update in payroll computer system which will be implemented by United Systems at \$5000 for programing, \$695.00 for training and \$312.50 for reporting upgrade. On motion duly made and seconded, the purchases were approved.

## **RE: AIR CONDITIONER REPLACEMENT**

The Auditor reported that one of the air conditioner units at the Courthouse Annex had ceased operation and requires replacement. Messmer Mechanical has agreed to install a replacement for \$3,340. Adequate funds are in the maintenance account to pay for this work. On motion duly made and seconded, the replacement was approved from Messmer, which holds the annual maintenance contract.
