The Dubois County Council conducted a Public Hearing on September 10, 2014, at 5:45 p.m. in the Council Chambers of the Courthouse Annex. Present at the hearing were Council members Gregory A. RE: PUBLIC HEARINGS – 2015 BUDGETS

Being the advertised time, President Kendall opened the Public Hearing for comments on the 2015 County Budget, the 2015 Dubois Fire Protection Budget, the 2015 Dubois County Airport Budget, the 2015 Solid Waste Budget, and the 2015 Northeast Dubois Schools budget. There being no comments, on motion made by Jerry R. Hunefeld, seconded by Martha A. Wehr, the Council voted unanimously to close the Public Hearing.

Auditor Hopf requested an additional appropriation in the amount of \$1,200 from the Cum Cap Development Fund for the purchase of a laptop for the CASA Director. On motion made by Jerry R. Hunefeld, seconded by Shane M. Lindauer, the additional appropriation was unanimously approved.

Auditor Hopf requested an additional appropriation in the amount of \$5,700 from the Cum Cap Development Fund for a Printer/Copier/Scanner for Superior Court. On motion made by Martha A. Wehr, seconded by Barbara Mathies, the additional appropriation was unanimously approved.

Auditor Hopf requested an additional appropriation in the amount of \$5,700 from the Cum Cap Development Fund for a Printer/Copier/Scanner for Probation. On motion made by Gregory A. Kendall, seconded by Nick Hostetter, the additional appropriation was unanimously approved.

Auditor Hopf requested an additional appropriation in the amount of \$1,100 from the Cum Cap Development Fund for the Solid Waste District truck. On motion made by Nick Hostetter, seconded by Barbara Mathies, the additional appropriation was unanimously approved.

Auditor Hopf requested an additional appropriation in the amount of \$6,000 from the EDIT Fund for rental fees for the temporary housing of the ambulance while the Huntingburg station is being renovated. On motion made by Shane M. Lindauer, seconded by Martha A. Wehr, the additional appropriation was unanimously approved.
