The Director advised the Board that an error had been made in preparation of an August voucher of ArcMate (#306), reported as \$306, while the actual amount was \$325.21. On motion made and seconded, the voucher as amended was approved and payment as corrected was approved.

#### **RE: FINANCIAL REPORT**

The Controller reported that the balance in the District bank account, after payment of the above claims, is \$9,773.22. She also reported that due to a negative balance in account #307, a transfer was being made from account #313 to offset the negative balance. On motion duly made and seconded, the transfer was approved.

### **RE: ROUTE DRIVER**

The Director reported that recently retired Highway driver Charles Verkamp has been employed as a District route driver at a pay rate of \$13.20 per hour. Due to his prior County employment, he will not be subject to the probationary reduction. On motion made and seconded, the employment was approved.

#### **RE: TRASH ORDINANCE**

The Director also reported that the Commissioners had extended to the Carrico family an extension of time to pay a prior penalty for violation of the County trash ordinance. During 2015, 45 dump complaints have been investigated and reports filed. The Director reported on several trouble spots within the County being used for waste dumps.

# **RE: DISTRICT PROCESSING CENTER**

The Director reported that new LED lighting has been installed at the District Center. Also some improvements have been made to the furnace system.

#### RE: EQUIPMENT

The Director reported that the ISUZU truck has a cracked windshield which needs replacement.
